The Dogs of Guy Mason Alliance (DOGMA) is a group of Glover Park residents interested in the welfare of the dog park located at the Guy Mason Recreation Center. It is our intention to formally register the dog park through proper channels the government of the District of Columbia, Department of Parks and Recreation.

Please find attached our completed application and a petition signed by 62 patrons of the park. Our ANC Chairman said that they will send a letter of support on their own.

We are asking to remain in the current location and keep the existing size; additionally we would like to continue use mulch/wood chips as our surface. Despite certain limitations with the current space, your final rulemaking emphasizes the need for flexibility when registering a dog park and we do not foresee problems with our application.
