Shaded area is provided and is in good condition (CPSC 2.1.1).			
Seating is provided and in good condition.			
Playground has accessible route of travel.			
Trash receptacles are provided and are in good condition.			
Outdoor drinking fountains are provided and working.			
Play area is free of tripping hazards (CPSC 3.6).			
Play area is free from drainage problems.			
Separate play areas for ages 2-5 and 5-12 (ASTM 9.8; CPSC 2.2.3).			
Play area is visible from street to deter inappropriate behavior (CPSC 2.2.4).			
No signs of vandalism are present.			
Play area can clearly be seen at night.			
Fencing is provided where needed.			
There is access to bathrooms from play area.			
Playground does not contain: trampolines, swinging gates, multiple occupancy swings (except tire swings), rope swings, swinging dual exercise rings and trapeze bars (CPSC 2.3.1).

Playground equipment is manufactured and constructed only of materials that have a demonstrated durability (ASTM 4.1; CPSC 2.5.1).			
Appropriate use zones extend on all sides of structures (ASTM 9.2.1; CPSC 5.3.9).			
Overhead obstructions within play structure are min. 84" from each designated play surface (ASTM 9.8.4.1).			
Equipment is free of head entrapments (ASTM 6.1.4; CPSC 3.3).			
Equipment is free of splinters, sharp points, sharp edges (ASTM 6.2; CPSC 3.4).			
Equipment is free of protrusions (ASTM 6.3; CPSC 3.2).			
Equipment is free of entanglements (ASTM 6.4.2; CPSC 3.2).			
Equipment passes all crush/shear tests (ASTM 6.5; CPSC 3.1).			
Equipment is free of rust/chipping paint (CPSC 2.5.4).			
Equipment is free of loose or missing hardware.			
Play structures are anchored to the ground and not intended to be relocated (ASTM 5.3).			
Users cannot ingest, inhale, or absorb any potentially hazardous amounts of substances through body surfaces as a result of contact with the equipment. (ASTM 4.1.2; CPSC 2.5.4)			
Moving equipment such as swings and rotating equipment are located near the periphery away from circulation routes (ASTM 9.8.3; CPSC 2.2.3).			
Platforms, landings, walkways, and ramps do not trap water and accumulate debris (ASTM 7.5.2; CPSC 5.1.1).			
Guardrails and barriers are present on elevated surfaces > 20" when intended for 2-5, and > 30" when intended for 5-12 (ASTM 7.5.5.1, Fig A1.49; CPSC 5.1.3).			
Vertical distance between underside of swing seat and surfacing min. 12" (ASTM 8.6.1.5 (5); CPSC 5.3.8.1, Table 7).			
Swing chains free from rust or wear.			
Swing seats free from tears or wear.

Protective surfacing is in good condition and in accordance with critical fall heights (ASTM 13.2.1; CPSC 2.4).			
Surface is free from debris (ASTM 13.2.2; CPSC 4).			
Surface is free of standing water and drains well (CPSC 2.4.2.2).			
Concrete footings are covered (CPSC 3.6).			
Playground border/edging in acceptable condition.

All play structures have warning labels (ASTM 14.4).			
Signs provide information regarding age of users (ASTM 15.2.1; CPSC 2.2.5).			
Freestanding signs are located outside fall use zones (ASTM 15.4.1).			
Manufacturer's identification appears, is durable, and is placed on the play structure (ASTM 14.4.1.4).			
Signs on all bordering streets advise motorists that a playground is nearby.			

ACCESSIBILITY	Yes	No	
Ramps are 36' min. wide, w/ running slope between 1:16 and 1:12. Max. horizontal run is 12' (ASTM 7.2.4).			
Landings have min. 60" diameter at top and bottom of each run when there is a change in direction, or it must be equal to width of ramp (ASTM 7.2.5).			
Play area use zone has accessible safety surfacing to all accessible play components (ASTM 7.1.1).			
Continuous handrails are provided on both sides of stairs w/ > 1 tread (ASTM 7.2.6; CPSC 5.2.3).			
Handrails have diameter between .95-1.55" (ASTM 7.2.6.4; CPSC 5.2.2).			
Wheelchair accessible ramps that require barriers have handrail 26-28" high on each side of ramp (ASTM 7.5.6.2).
