# SAFETY TIPS & INJURY PREVENTION



Never hang over fences or put your hands through fence openings to touch a dog, even one you know.

Avoid rough games such as tug-of-war, jumping up for toys/food, and wrestling - all could lead to injury if the game gets out of hand.

Never tease or hit a dog or pull ears, tail or feet and let sleeping/eating dogs alone!

Leave dogs with puppies alone. Some mother dogs may get very protective.

If an unknown dog approaches you, remain calm and quiet. Stand still and do not look the dog directly in the eyes. If you are boring, there is a good chance the dog will move on. Ultimately it is the owner who determines how safe their dog will be!

### **Licensing and Fees**

Dog licenses are issued by the DC
Department of Health's (DC Health) Animal services program. Dog owners must show proof that their pets have had rabies and distemper shots and renew their dog's license each year. # WHAT DOES THE LAW SAY?

## Leash your dog, it's the law

Under the Animal Control Act, all dogs on any public space in the District, other than in a dog park designated by the Department of Parks and Recreation, must be firmly secured by a leash at all times. DPR dog parks are designated by signage approved by DPR, and do not include fenced-in or open areas meant for other uses.



Except for services dogs, all dogs are prohibited on children's play area and on DPR athletic fields. With the District's increasing dog population, it's important to have the latest information about responsible dog ownership and how your pet impacts our environment and others. Pet waste and four-legged traffic are harmful to the health of our patrons in our recreational spaces. To ensure safe and sanitary conditions for everyone, please do not allow your dog onto DPR athletic fields.

## Pick up after your dog Fines \$150 -\$2,000

Dog waste transmits diseases, attracts rats, kills grass, and pollutes waterways.
Use a bag to pick up your dog's waste and then dispose of it in a trash can.

### What are the consequences?

Each person who violates DC's leash laws shall pay a fine not to exceed \$25 for the first violation, \$50 for the second violation occurring within a 24-month period, and \$100 for each subsequent violation occurring within a 24-month period. Additionally, civil charges can be filed if a dog injures a person while at large, lack of knowledge of the dog's vicious propensity standing alone shall not absolve the owner from a finding of negligence.
