## **Rec for ALL Community Grant Pre-Application Meeting Questions**

1. Is there an opportunity for renewal, and if so, what is the timeline for additional funding after September 30<sup>th</sup>?

The Notice of Grant Award (NOGA) will have option years placed within the agreement. Exercising the option year depends on need, budget and performance of the grantee.

2. You stated the program has to run for a minimum of 6 weeks, but what is the required frequency per week (per month if longer than 6 weeks)?

This is up to the organization and their proposed program design.

3. When do you plan to announce the awardees? When can awardees begin work?

DPR plans to award the grant in the month of April. Once the agreement is signed the Grantee can begin work.

4. What is the application summary?

A high level of application. (requested amount, Number of participants, etc.)

5. Must the business be registered in DC to participate?

For the Programming Grant – all applicants must have a DC Business License

6. Are there a minimum of participants?

The number of participants should speak to the program design and budget.

7. If the program charges a participation fee, would that by itself impact the ability to access the program grant? Does the offered program have to be free for kids?

If there is a participant fee it should be included in the budget. DPR does not expect participants to pay for program services.

8. Program Foundation is in DC; however, we use another building on Marlboro Pike. Are we able to submit a grant for both locations or 1 for the entire business?

All programs should be operated in the district.

9. Can we just use the programming grant to allow participants in our program free of change? Meaning the grant covers the program cost and would be sent to the parents.

Organizations can incorporate cost with their budget. The money should not given to parents directly.

10. For the programming grant, do you need full resumes for key staff or do short professional suffice?

Organizations must include the resumes.

11. For the programming grant, is it okay that 14–18-year-old youth are paid through MBSYEP? Our program includes occupational training.

You can use MBSYEP participants if the organization is not receiving additional grant funds for the same participants.

12. Can an organization be awarded a programming grant and a SEE grant in the same year?

Yes, an organization can be awarded both.

13. If we have general liability insurance, will that cover the sexual abuse insurance you mention? One of our existing programs works with students in DCPS, so I imagine we have this is but not certain if our insurance is specifically related to sexual abuse.

An organization will have to check with their insurance carrier to know if they are covered for Sexual Abuse Molestation.

14. Can you submit more than one application with one entity?

Organizations can apply for each grant category once.

15. Is it a minimum of days per week if we meet with the kids?

No.

16. Do trips have to stay in DC?

No.

17. My program is operating in the District and we transport the kids to our farm in PG county, is that fine?

Yes, as long as the transportation cost is supported by the organization.

18. Can you be a mobile company?

This depends on the location of the program services.

19. Are signed permits proof of occupancy?

Yes.

20. For the summer and fall season, can we use historical permits?

No, you permit must current.

21. Is there a time limit for the SEE Grant required like the minimum 6 weeks for the programming grants?

No.

22. Who is the certificate good standing issued by?

DPR will not accept a Certificate of Good Standing. Organizations must have a Certificate of Clean Hands. See link: <u>MyTax DC</u>

23. Is the grant only for youth or are with disabilities eligible?

The grant is for youth ages 6 to 18 which includes youth with disabilities.

24. Can we get a copy of the slides in the presentation emailed?
