**SUBJECT: Dog Park Application** 

Director Anderson:

This letter, along with attached documentation, is hereby submitted by The Northern Ward 4 Dog Park Group (the "Group") as part of their dog park application. The Group has spent the past year and a half meeting, discussing, and planning for a dog park at or near Takoma Recreation Center. Our group contains hundreds of Ward 4 residents who have been active in attending informational meetings, events, and education sessions related to establishing a dog park in Ward 4.

The Group has been following the dog park application process established by DPR and set forth in DPR's Dog Park Application Packet. Our Group requests that DPR continue to follow the established process and afford the Northern Ward 4 Dog Park Group, as well as the residents of Ward 4, the same due process that has been given to other dog park groups and communities throughout Washington, D.C.

Finally, it is our Group's understanding that DPR has considered or may be considering changing or amending the dog park application process. Given that our Group has been following the published and approved dog park application process since 2014, we request that our Group and our Group's application be subject to the dog park application process that is currently in effect.

The following document contains our group's formal application, documentation associated with the application, and petition signatures.

# Need for a Dog Park:

**Current Amenities.** Exhibit 1 displays Ward 4's lone dog park in the Ward, the Upshur Dog Park ("Upshur"). Our Group has determined that Ward 4 has the least amount of dog park space of any Wards located in D.C. which offer fenced-in, off-leash dog park amenities. As the population in Ward 4 continues to grow, and as more pet-friendly buildings are erected throughout the Ward, there needs to be adequate space where residents can take their pets for exercise and play.

**Current Option:** Upshur is not a viable or realistic option for many Ward 4 residents. Many Ward 4 residents lack the transportation methods needed in order to reach the only dog park in Ward 4. Ward 4 residents who are elderly or disabled often lack the means or the ability to travel several miles in order to exercise their pet or service animal. Additionally, Upshur is often frequented by residents from Ward 1, as its location is closer to many Ward 1 residents than Ward 4 residents. As seen in <a href="Exhibit 2">Exhibit 2</a>, some residents in Ward 4 live almost three (3) miles away from Upshur.

**Registered Dogs.** Based on information obtained from Mr. Edward Rich, Deputy General Counsel at the D.C. Department of Health, and highlighted in Exhibit 3, the Ward 4 zip code 20011 has the second highest number of registered dogs (253) in Washington, D.C. The Takoma Recreation Center is located in zip code 20011 and the majority of our petition signers and group members live in close proximity to the Primary Site that our group is proposing as part of this application.

**DPR's Plan.** The Play Master Plan (the "Master Plan"), created during Mayor Vincent Gray's administration highlights the importance of dog parks in the community. The Master Plan included a vision of a dog park in the vicinity of the Takoma Recreation Center (Outdoor Facilities Vision, Page 37) (included as <u>Exhibit 4</u>). Dog Parks were included in the Master Plan as part of the "Outdoor Facilities" grouping, and these facilities were selected and included in the Master Plan based on need and proposed methods of meeting demand as determined by DPR.

**Ward 4 Growth.** The Northern area of Ward 4 has been experiencing rapid growth and the needs of residents in the area continue to evolve with that growth. An example of this is Takoma Central, which is pet friendly, as evidenced in <a href="Exhibit 5">Exhibit 5</a>. Residents in various neighborhoods throughout Northern Ward 4 have expressed strong interest in a centrally located dog park where they can let their dogs run, play, and exercise. Dog Parks are community amenities in alignment with DPR's mission to 'enhance the quality of life and wellness for DC residents and visitors by providing equal access to affordable and quality recreational services...' All of the supporting groups who petitioned for existing dog parks located throughout Washington D.C. went through the same processes and procedures established as a result of the Dog Park Establishment Amendment Act of 2005. Our Group has worked diligently to follow these established processes and procedures. The Group feels strongly that these processes and procedures should remain consistent for our application process, and that no special amendments, changes, or considerations be made in regard to that process.

# Why Takoma Recreation Center?

**Ample Open Land.** There is over 6 acres of unused District-owned Parkland at Takoma Recreation Center (Exhibit 6). Our Group believes that there are multiple sites available at Takoma Recreation Center where a 10,000 square foot dog park could be built. The Chair of the Advisory Neighborhood Commission in which this dog park would be located has said "There is enough space at Takoma Recreation Center for everyone."

**Middle Ground.** Takoma Recreation Center is a centrally-placed location in the Northern Area of Ward 4. Placing a dog park at our Primary Site would allow for neighbors in or near Portal, Shepherd Park, Takoma, Brightwood, Lamond-Riggs, and Manor Park to have a walkable and nearby dog park.

**Site Selection.** The primary site that our Group has selected is over 300 feet from the closest private residence. The primary site is also over 450 feet from the closest church (Promised Land Baptist Church) and dog park visibility from the Church would be partially to completely obscured by existing trees and shrubbery. An example of our Group's Primary Site is included as Exhibit 7.

# Design:

**Triangular Space.** There is a natural triangular space that is located next to the Williams Building and Takoma Recreation Center's Indoor Pool Building. We propose placing a 10,000 square foot dog park at this location. Exhibit 7 displays where this site would be located.

**Standard Amenities.** Our group proposes that this site receive all of the basic infrastructure (fencing, flooring, water hose, waste bags, etc.) that is provided to all dog parks that are located in Washington, D.C.

**Additional Amenities.** In addition to the standard amenities, our group would like to install 5 foot high shrubbery which would be placed on the northwest side of the triangular space. This shrubbery would exist to cut down on any noise and would also make the dog park less visible to homeowners on 5<sup>th</sup> Street and Van Buren Street. Our Group would also like to pay for and install a memorial bench at the Site.

# **Petition:**

**Historical Petition Numbers:** Based on information obtained from DPR's General Counsel, Ms. Amy Caspari, our Group determined that the largest petition submitted to DPR to date was the Shaw Dog Park Group's 2008 dog park application containing 445 signatures. This information is included as <a href="Exhibit 8">Exhibit 8</a> and <a hr

**Initial Petition:** Prior to conducting the 300 Van Buren Street, NW petition, our Group collected signatures for a petition for the 4<sup>th</sup> and Whittier. This petition (attached) contains 290 signatures. Had our Group submitted this petition it would have been the second largest petition ever submitted to DPR. A small sample map of these signatures is evidenced in <u>Exhibit 9.</u>

A Historic Petition: After learning that the 4<sup>th</sup> and Whittier Site was not a viable location, our Group conducted an entirely new petition. At the present time this application contains approximately 550 signatures from members of Wad 4 and throughout the D.C. community. It is our Group's belief that these signatures make up the largest petition by D.C. residents ever filed for a dog park in Washington, D.C. Attached as <a href="Exhibit 10">Exhibit 10-A</a>, and <a href="Exhibit 10-B">Exhibit 10-A</a>, and <a href="Exhibit 10-B">Exhibit 10-B</a>, are maps containing some locations of petition signers

Additionally, our group has attached letters of support, as <u>Exhibit 11</u> through <u>Exhibit 11-E</u>, that we have received from members of the community.

Considering Both Petitions: The language that is included on DPR's petition pages, and the language that petition signers sign off on is: "By signing this petition, I support the establishment of a dog park in this community." (emphasis added). Because our Group was not able to recapture every signature from our initial petition, we would like DPR and the DPARC to take into account and consider the 290 signatures that are included in this initial petition. As of today's date there are many more community members who have requested to sign our Group's petition, yet are unable to do so logistically.

Our Group believes that we have a strong case for installing a dog park at the Takoma Recreation Center. There is plenty of land available, there are plenty of dogs in the community, and there is a considerable amount of support for the park amongst neighbors and Ward 4 residents. We hope that you strongly consider our application and give our group the same consideration procedurally that other dog park groups were afforded.

Dear Mr. Cohen:

Per your September 4, 2015 FOIA express request, 2015-FOIA-04674, we are providing, with this letter, information pertaining to your request "please provide the total number of petition signatures included in all DC dog park applications. Please provide total amount of money spent (on construction) for each existing dog park in Washington D.C. [from 2004-2015]."

While the Freedom of Information Act, D.C. Official Code §§ 2-531 et seq. provides for the right to public documents, and your request is not for documents, DPR has processed the request anyway with the information that is available to us. The information was placed in the chart attached and the spaces indicating n/a are not available to DPR at this time. We are still trying to get this information and we will let you know when and if it is available.

Please know that under D.C. Official Code § 2-537 and 1 DCMR 412 you have the right to appeal this letter to the Mayor or to the Superior Court of the District of Columbia. If you elect to appeal to the Mayor your appeal must be in writing and contain "Freedom of Information Act Appeal" or "FOIA Appeal" in the subject line of the letter as well on the outside of the envelope. The appeal must include (1) a copy of the original request; (2) a copy of any written denial; (3) a statement of the circumstances, reasons, and/or arguments advanced in support of disclosure; and (4) a daytime telephone number, and e-mail and/or U.S. Mail address at which you can be reached.

The appeal must be mailed to: The Mayor's Correspondence Unit, FOIA Appeal, 1350 Pennsylvania Avenue, N.W., Suite 316, Washington, D.C. 20004. You may remember me as the former consultant to Singh at Cedar Crossing, or you may remember me as the guy that auctioned off a couple of exclusive bottles of wine at Ethan Landis' office for Muriel's fundraiser

At least I hope you do. I live on Elder St NW, at the corner of 9th. Love the neigborhood, and my neighbors. It's great to see over the past couple of years the growing numbers of baby strollers and bikes with Training wheels on the streets. Even so, those of us with 4 legged family are only too acutely aware that in the blocks bounded by Georgia Ave, Fern, Blair Road and Aspen, there are roughly four times the number of households with canines than with kids.

A new baseball diamond was just installed at TEC, and already a couple of games have been played. But on an annualized basis, that baseball diamond will enjoy very few play hours when compared to an off leash area in the neighborhood, which will be utilized every day, four seasons, twice a day, by many many more people. Notice that I have refrained from calling this much needed space a "dog park". It is a people park, where people can gather and interact, not just sit on a bench and stare at their smart phones. That those people also get to interact with a range of effervescent, spirit raising canines, is just a plus.

I was involved in starting two off leash areas back in Atlanta, and the presence of t hose areas did a great deal for making the neighborhood more desirable. Many people came to hang out even though they didn't have a dog. Some mothers brought their younger....and I mean under 5 yrs old...kids so they could learn how to interact with with dogs and not grow up afraid of them

You don't know how funny it is to see an 18th old baby running underneath the belly of an enormous Great Dane, and laughing his head off!

All this is to say, many, many of us here in Northern Ward 4 hope you will take the time to appreciate our needs, support our efforts, and encourage the establishment of an off leash recreation area for people and their best friends.

While I am indifferent because I don't have a dog, there is a few considerations that need to made for the future of the community in which the dog park will be beneficial.

- 1. There is no such resource in this part of Ward 4.
- 2. There is going to be a significant influx of new residents with the following projects which are being built or will be built in the immediate future which are multifamily units with no yards: the apartment project by the metro station, the douglas development project behind CVS, the space just purchased on Georgia ave across from Walter Reed, never mind Walter Reed redevelopment itself. Likewise there will be others in the future as well.

As much as I find it pleasant people walking around their dogs in this community, I am cognizant of the issues which arise as a result of this community transitioning from one that is relatively sleepy single family homes and douplexes, to one with more apartments. I think the reality is the dog park transitions from a "nice to have", to a kind of needed. Yes, those with fenced in yards with dogs this is not a huge concern. But for the future of the community it is something that would improve the quality of life. Plus, I think people tend to forget we have the humane society and one of the better pet stores right as part of our community as well. This is already a big part of our local culture. There is erosion, recently high schoolers have begun gambling there in the afternoons, and overall, it is an area that is difficult to use in any kind of recreational manner because the concrete slabs make it unsuitable for sports, picnics, or really anything.

We moved here after living directly across the street from the Congressional cemetery which was also an off-leash dog area and we very much appreciated the friendly and social activity associated with 4-legged friends.

We would love to see the park serving as many as possible in the community and there are so many dog owners, I can only imagine that this would increase the number of people (and pets) well served by our park space if outfitted with appropriate equipment and ongoing maintenance.

Dear Commissioner Austin,

Thank you for taking the time to read this email and for organizing the special meeting last night at MPD's 4D Community Room. I attended the meeting until 8:45pm; I didn't expect the meeting to go so long and had to leave before I had the chance to say what am about to say in this email.

I am a homeowner living at 715 Tuckerman Street NW, in former Commissioner Grant's SMD. I have lived there for over 5 years and have lived in the area over 8 years. I am currently not a dog owner, but am in full support of establishing a dog park in 4B. I used own a dog many years ago and my finacè are in the process of adopting two dogs. I am not a "core member" of the dog park group, but I support the initiative, have signed their petition and hope that you and a majority of the ANC will vote to proceed with establishing the dog park.

I completely understand the reservations of the few, vocal community members against the dog park, yet I believe that their arguments against the park are unfounded. Concern was voiced over the dog park leading to an increase in attacks by dogs on people, yet the DOH representatives stated that this is a myth and the DPR representative stated that he's never been contacted about such attacks. A gentleman voiced concern over community events not being able to be held in the park due to the proximity of the dog park, yet also stated that the closest the events reach the proposed placement of dog park would provide "40 feet" of space between the fence and the perimeter of the event - the equivalent of a 4-storey building.

There is concern about noise from the park disrupting church services and the peace and quiet of local residents in the immediate. I believe that residents supporting and planning to utilize the dog park are responsible dog owners and that they are as concerned with noise as folks who don't have dogs. I also believe that residents against the dog park have more to be concerned about from dog owners in the community that are not responsible dog owners. Lastly, there is a concern that residents were not provided sufficient notice regarding the dog park. I found out about the discussion of the dog park in Spring of this year; 531 signatures have been received since August; I firmly believe that the Mr. Cohen and his colleagues

have canvassed the community to get input from the members about whether they support the park as well as its proposed locations and alternate sites. Just because a few residents didn't answer the door when Mr. Cohen and the group knocked on it doesn't mean that an entire effort should collapse. There has been ample opportunity for these residents to interact with the dog park group. It is quite apparent that there are more people in favor of allowing a dog park to be built than there are those vocally against it, including other members of the ANC Commission.

On account of the unfortunate passing of Fred Grant, I understand from ANC rules that you have the ability to endorse the creation of the dog park in his place as the ANC Commissioner of 4B. I hope that you will be able follow through with his stated desire to see a dog park constructed in 4B. I wish you the best in trying to persuade your colleagues on the ANC to vote for the application of the dog park to proceed.

Dear Chair Austin and the Commissioners of ANC 4B:

My name is Scott Giacoppo, and I am the Chief Community Animal Welfare Officer for the Washington Humane Society. As you may know, WHS is an animal-welfare agency chartered by Congress in 1870. In addition to handling animal care and control throughout the District, we also operate all of our cruelty investigations and an animal adoption center and training facility within ANC 4B, on Georgia Avenue between Fern and Geranium.

I have recently learned that residents in the Takoma/Brightwood neighborhood are working to establish a dog park at the Takoma Recreation Center. On behalf of WHS, we wholeheartedly support this proposal. Many residents in this neighborhood (and, of course, all over the city) include dogs as part of their families, and to have a nearby dog park would be a wonderful addition-for everyone. Dog parks allow pets to learn vital socialization skills, to exercise and remain healthy, and to spend time with their owners, all in a safe, fun setting. Plus, the dog park would serve as a gathering place for the community, lead to more foot traffic and thus eyes on the street, and promote pet registration (since I all of the dogs would need to be registered to use the park).

Placing the park at the existing Takoma Recreation Center seems like a perfect use of that space, and based on the success of other parks in the District I believe that it would make this great neighborhood even better. We at WHS hope that you will strongly consider this initiative.
