Dear DPR:

At today's public meeting of Advisory Neighborhood Commission (ANC) 5E, the issue of whether to support the Edgewood dog park application was on the agenda and the following facts were determined:

1. Edgewood Recreation Center and DPR Triangle Park (Franklin/Lincoln/4th Street NE) located in Single Member Districts (SMD) 5E10 and 5E01.
2. A number of residents of SMD 5E10 and 5E01 have been asking for a dog park to be created in the neighborhood for a number of years. Surrounding SMD neighbors in 5E have also voiced their support as evidenced by the number of signatories on the collected petition.
3. At a duly noticed and well attended meetings of SMD 5E10 residents debated and supported the establishment of a dog park in the Edgewood neighborhood.
4. At a duly noticed and well attended meetings of Friends of Edgewood Recreation Center residents debated and supported the establishment of a dog park in the Edgewood neighborhood.

Based on these findings, ANC5E voted in favor by a majority with voice vote to support the Friends of Edgewood Recreation Center Dog Park Application to create a DPR Dog Park on DPR property in the Edgewood Neighborhood of Washington, DC focusing on the triangle park space.
