- Provide ANC5E with an invoice for each recording

Payment

ANC5E will provide Woge Media with a payment of \$400 per meeting video via check upon receipt of monthly invoice.

Oversight and Communication

General oversight of this Contract, as well as related communications on behalf of ANC 5E will be the responsibility of ANC 5E Commissioner Sally Hobaugh.

Cancellation Fee:

With the exception of weather-related cancellations or rescheduling, ANC5E must give Woge Media notice of cancellations or scheduling changes at least 24 hours prior to the shoot, or they will be charged a \$150 cancellation fee by Woge Media.

Termination of Contract

This contract will terminate on January 1, 2017 or upon thirty (30) days written notice by either party to the other. Upon termination, any unpaid invoice shall be paid within 15 days.


Extension of Term

The term of this contract may be extended at any time by written agreement of the parties subject to the ratification of ANC 5E.


